Membership dues are payable in full by January 31 of each year. Full club dues are required from January 1st through September 30 of the current year. One-half dues are required from October 1st through December 31 of current year. Initiation fee of \$15.00 N.R.A. membership is required. The combination of the locks will be changed four times each year and all paid up members will receive the new combinations at the time of membership or renewal.
